Background

The Biomass Suppliers List Advisory Panel was set up to discuss and input into how the BSL is run and make recommendations to the Department for Business, Energy and Industrial Strategy (BEIS); formerly (DECC).

The panel is made up of various industry and BSL supplier representatives.

The BSL is seeking to appoint additional candidates to join the Advisory Panel to provide advice and recommendations to BEIS regarding the present and future direction of the BSL.

1. Voting Process

On June 11, we asked BSL users to nominate themselves to sit on the Panel. We have received a few nominations; some for multiple categories. Nominees for categories that were over-subscribed have been shortlisted following an initial suitability assessment, which included verifying that nominees are BSL authorised where applicable. We are now inviting you to vote on your preferred candidates and ask that you read the following information before voting.

Rules for voting

1. You can only vote for the candidate in the categories that you are registered for on the BSL, e.g. if you are a Producer of woodchip produced from virgin timber, then only vote under the Producer, woodchip and forestry categories. To do this, you will need to provide one of your BSL authorisation numbers that matches the category you are voting in. For a short summary of each of the candidates, see the Appendix.
2. Only one voting form will be accepted per organisation.
3. You can only vote for one candidate in each category.

Appendix – Candidate Summaries

Self-Suppliers
